SECTION 3 - HAZARDS IDENTIFICATION

SECTION 5 - FIRE FIGHTING MEASURES

SPECIAL FIREFIGHTING PROCEDURES: Water may be used to cool closed containers to prevent pressure buildup and possible autoignition or explosion. Evacuate area and fight fire from a safe distance.

SECTION 6 - ACCIDENTAL RELEASE MEASURES
