## E. ACCIDENTAL RELEASE MEASURES

**Small Spill**

## F. HANDLING AND STORAGE

Handling

Hydrocarbon solvents are basically non-conductors of electricity and can become electrostatically charged during mixing, filtering or pumping at high flow rates.
