# Memorandum of Understanding

This Memorandum of Understanding is entered into by and between the Grand Valley Local Schools Board of Education (Board) and the Grand Valley School Support Personnel (Association) this 21st day of November, 2022.

WHEREAS, the Board of Education and Association have entered into a Collective Bargaining Agreement (CBA) which is effective from July 1, 2021 through June 30, 2023;

WHEREAS, the parties have entered into certain agreements with regard to the Substitute Bus Driver wages that affects the Association and in that regard, desire to memorialize their agreements pertaining to same;

NOW THEREFORE, IT IS HEREBY AGREED by and between the Board of Education and the Association that the following language shall constitute their Agreement as it relates to this matter:

Effective November 21st, 2022, the language in Article 17.0 W. will be modified to:

W. Substitute drivers will be paid at the rate of \$15.00 per hour, unless or until they have substituted for thirty (30) days for the District, at which point the Substitute Bus Driver wage will be paid at Step 1 for Bus Drivers in the salary index. Regular drivers who substitute on routes will receive their regular rate of pay for such substitution.
