# RESOLUTION DECLARING IT NECESSARY TO LEVY A RENEWAL TAX IN EXCESS OF THE TEN-MILL LIMITATION

(Ohio Revised Code Sections 5705,215 and 5705.25)

WHEREAS, the territory of the School District is included in the Ashtabula County Educational Service Center (the "ACESC") which has declared its territory to be a county school financing district pursuant to Ohio Revised Code Section 3311.50 and shall be referred to as the "Ashtabula County School Financing District" (the "ACSFD"); and

WHEREAS, this Board has not adopted a resolution to withdraw the territory of the School District from the ACSFD; and

WHEREAS, the ACSFD is currently levying a 1.50 mill, five-year levy approved by the voters of the ACSFD on May 7, 2019, and first placed on the tax list and duplicate in 2019 (the "Existing Levy") for collection years 2020 through 2024 for the purpose of current expenses for the provision of special education and related services within the territory of the ACSFD; and

WHEREAS, this Board, in conjunction with the boards of education of the other school districts the territory of which is included in the territory of the ACSFD, has identified the need for a renewal tax outside the ten-mill limitation for the purpose of current expenses for the provision of special education and related services within the territory of the ACSFD; and

WHEREAS, a resolution identical to the resolutions adopted by the other school districts whose territory lies within the territory of the ACSFD must be passed and certified by this Board to the ACESC authorizing the Governing Board of the ACESC, as taxing authority for the ACSFD, to adopt and submit to the Ashtabula County Board of Elections a resolution providing for the submission to the electors of the ACSFD the question of levying a renewal tax;

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Grand Valley Local School District, Ashtabula County, Ohio, a majority of all of the members elected thereto concurring, that:

Section 1. Pursuant to Ohio Revised Code Section 5705.215, this Board hereby requests the Governing Board of the ACESC, as taxing authority for the ACSFD, to submit to the electors at the election to be held on November 7, 2023 the question of levying a renewal of the Existing Levy for the purpose of

current expenses for the provision of special education and related services within the territory of the ACSFD. All of the territory of the School District is in the ACSFD.

Section 2. Such renewal tax levy shall be at an annual rate not exceeding 1.50 mills for each \$1 of taxable value, with the corresponding amount in whole dollars for each \$100,000 of the county auditor's appraised value as certified by the Ashtabula County Auditor, upon the entire territory of the School District, for a continuing period of time.

Section 3. Such renewal tax levy shall be placed upon the tax list and duplicate for the 2024 tax year (commencing in 2024, first due in calendar year 2025), if a majority of the electors voting thereon vote in favor thereof.

Section 4. The Treasurer of this Board is hereby authorized and directed to promptly deliver a certified copy of this resolution to the Governing Board of the ACESC with instructions to adopt and submit to the Ashtabula County Board of Elections a resolution providing for the submission to the electors of the ACSFD the question of levying the renewal tax.

Section 5. It is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Ohio Revised Code Section 121.22.

#### **DRAFTING**

Students will learn blueprint reading as it relates to architecture and construction. Students will use scaling, orthographic projections, dimensioning practices, symbols, notations, and abbreviations to perform area calculations and to interpret floor plan, section, and elevations. Using construction plans, students will identify problems or shortcomings related to the layout and installation of materials for the project.

2. Info technology was added as a graduation requirement and set at half credit to be accompanied by financial literacy. Financial literacy was added as a state graduation requirement beginning with the Class of 2026. It must appear on their transcript as half credit course.

# INFORMATION TECHNOLOGY

This course focuses on the understanding of computer hardware, software and current technology in today's world. Word processing and keyboarding skills are emphasized as well as application software that incorporates spreadsheet and presentation programs. This course is required for all sophomores.

#### FINANCIAL LITERACY

Students will gain an understanding of the following concepts: comparing economic systems, family economics, international economics, consumerism, personal finance and economic opportunities in today's world. This course is required for graduation.

3. The English Department reconstructed their department to give more variety in subject areas and flexibility in English topic selection. Courses are designed for students to pick one writing intensive and one reading intensive course each semester.

# **ENGLISH SEMINAR (SOPHOMORES)**

This course is organized around the study of various genres of literature, including novels, non-fiction expository texts, drama, and poetry. The course emphasizes instruction in the development of clear argumentation, support, and structure of analytical paragraphs and essays. Students will construct multi-paragraph essays that respond to non-fiction texts, analyze literature, and persuade an audience. Analysis is a key skill that students will develop as they explore the significance of a piece of text and the elements of writing that create meaning. Students will also be challenged to grow in their practical language skills through class discussions, formal and informal writing assignments, creative projects, and oral presentations. Students will continue to develop grammar, punctuation, and vocabulary skills

\*\*Students will take this course in the fall of their sophomore year. This course is required for the ELA II end-of-course exam.

## BASIC DRAMA TO STAGE COMBAT

Drama has great fun in store for you with instruction in stage direction, movement, acting techniques, vocal techniques, and blocking. Students will learn the craft of pantomime and improvisation, and end the semester with stage combat techniques. Students will utilize these skills in class mini productions.

#### LAYOUT & DESIGN

Layout and design are the building blocks of any document from a Google Slide, to a newsletter, to a school newspaper. Learn to give your work structure and flow by using the five basic principles of design: Proximity, White Space, Alignment, Contrast and Repetition. Students will use these principles in their work for other classes, and by producing a school newspaper composed of student work in the journalism class and English Classes.

#### DRAMA

This course explores the relationship between the young actor and the craft of acting. Students will explore themselves as the instrument of acting. The course covers improvisation, pantomime, voice and diction. Students will learn the basics of acting, varieties and structure of drama and methods of evaluating plays and movies. Students will focus on play/character analysis, and the

rudiments of theatrical production. There are several projects culminating with the performance of a monologue as a final exam.

#### ONE ACT PLAYS

In this course, we'll look at the challenge of short plays. We'll read a few one-act plays live in class - with students playing the parts. And we'll try our hand at writing our own short plays - comedies, dramas, adventures and farces!

#### **BOOK vs FILM**

In this course, we will think about what happens when literature is adapted into films and moving images, and how both literature and film make the world intelligible in ways that it would otherwise not be. In particular: we will consider what these art forms help us to see when it comes to the various ways we try to understand one another — what it looks like to succeed or fail at 'getting to know' one another politically, socially, economically, historically and so on. And we will think about how films 'adapt' literary works; how one medium 'deals with' the other, and therefore how their encounter shows the limits and power of each.

#### **SPEECH**

This course will provide high school students of all ability levels with an opportunity to develop an essential form of communication: public speaking. This course will stress the impact of oral communication on one's role as a communicator. This course will aid students who are apprehensive about public speaking situations as well as further advance the skills of those students who excel in this arena.

### **CONSPIRACY THEORY ANALYSIS**

This course examines several events through the conspiracy theory lens. Students will understand and critique the conspiracy theories. Its purpose is not to teach students to believe in conspiracy theory, but rather to encourage them to consider how conspiracy theory can help us to understand the anxieties that tend to surround rapid social and cultural changes.

#### **GOTHIC LITERATURE**

This course focuses on the major themes found in Gothic literature and demonstrates how the core writing drivers produce a suspenseful environment for readers. It presents some of the recurring themes and elements found in the genre. As they complete the course, students gain an understanding of and an appreciation for the complex nature of Gothic literature.

#### **FANTASY/SCIENCE FICTION**

This course is primarily discussion based and focuses on collaboration and student centered instruction with the instructor as facilitator. Students will study culturally influential texts in the genre of fantasy and science fiction, and will analyze, synthesize, and compare/contrast different texts over various mediums. Focus will center on choices made by the author, multiple

interpretations of texts, and analyzing thematic and symbolic developments throughout individual and multiple texts.

#### **MODERN COMMUNICATION**

This course will focus on studying different forms of modern communication, including web content and podcasting. Students will engage in analysis of various forms of texts as well as cultural artifacts in order to learn about modern methods of communication and the results of that communication stemming from concepts of author/creator choices, thematic choices, symbolic use, and the use of argumentative rhetoric. Students will then engage in the creation of modern communication after careful consideration of topic generation, research, and studying rhetorical analysis.

# **ACADEMIC WRITING (PRE-CCP)**

This course is a pre-CCP level introduction to academic writing. Students will be engaged in the components of academic writing considering audience, word choice, effective sentencing, and productive revision in order to prepare themselves for the college level of essay work. This course will entail collaborative work and critical reading of non-fiction texts in addition to the composition of academic writing.

#### **CREATIVE WRITING**

This course will incorporate critical reading of both fiction and non-fiction texts in order to evaluate and analyze the author's use of language, thematic elements, and symbolism in order to make sense of the world we inhabit. Students will use that analysis as a foundation for the creation of original worlds, original characters, and original works of fiction (stories, poems, songs, etc.) and non-fiction (memoirs, journals, creative nonfiction, etc.).

# YOUNG ADULT LITERATURE

This course focuses on texts designed for the young adult age group. Readings include literature in a variety of genres with an emphasis on diverse voices and perspectives, including strong characters that are pushing boundaries and exploring their world in an effort to find themselves. Readings, discussions, and writing assignments will require critical analysis of the literary features of these books, including analyzing the themes and characterizations that make the works appealing to their age group.

#### **JOURNALISM**

This course will focus on the study of journalistic topics and the creation of original works of journalism, and presents students with the skills and information that are essential for reliable, accurate, and independent news reporting. Students will have the opportunity to create products including but not limited to: school paper/newsletter, printables for extracurricular activities, supplemental material for GVTV and Interactive Multimedia, etc.

#### DYSTOPIAN LITERATURE

This course will focus on dystopian texts in various forms, including novels, short stories, film, and other genres. Dystopian texts explore social and political choices made by individuals and cultures that create a nightmarish world; these narratives serve as criticism and commentary on social issues, both current and past. Students will have to discuss and analyze the ways that fictional and real societies affect and influence us as citizens, in addition to critical and creative writing.

#### LITERARY CRITICISM AND THEORY

This course establishes a foundational capacity to read, talk about, and write about critical and literary theory. Students will read a number of literary texts from multiple genres, including but not limited to: novels, short and long prose, poetry, and drama - and write critical responses to those works using the theoretical tools presented in the class. It is a deeper look into creating and understanding meaning in literature, and would be a great course to take for any considering CCP or AP in the future.

# **ENGLISH PATHWAYS (JUNIORS/SENIORS)**

This course is designed to improve fundamental academic skills in reading, writing, and critical thinking. Class instruction emphasizes the development of paragraph and essay writing skills, reading comprehension, sentence structure, grammar and punctuation, and vocabulary in securing the passing of the state standardized testing.

\*\*Students will take this course if they have not passed their required ELA II end-of-course exam.

4. The Remediation Math course was added to help with students who have not been able to secure a 684 competency on the Algebra I or Math I end-of-course exam for remedial assessment knowledge,

#### **MATHEMATICS**

CREDIT

#### MATH REMEDIATION

This class focuses on reviewing and building foundational math skills so that students can better understand their current and future mathematical concepts. Students will dive deeper into Algebra I material and discuss basic geometry concepts. Classroom activities and projects are designed to strengthen math skills used in the real world.

**Prerequisite**: Students in this course are likely placed due to credit deficiency or lack of competency on the Algebra/Math 1 end-of-course exam.

5. The course catalog was updated with our departmental changes from Family and Consumer Science to Hospitality. Course descriptions were added which reflect the subject descriptions provided by ODE aligned to the hospitality pathway,

#### **FUNDAMENTALS OF FOODS**

Students will prepare food products and beverages according to standardized recipes. They will apply plating and presentation principles to deliver attractive menu items, establish food specifications and prep lists, and develop ingredient and portion control guides. Safety and sanitation, standard knife skills, and culinary math will be emphasized. Employability skills, leadership and communications will also be incorporated.

# **BAKING & PASTRY ARTS**

Students will apply food-science principles to prepare and bake breads, desserts and pastries. They will also use specialized decoration and presentation techniques to decorate cakes, cookies, pastries, and other baked goods. Students will select quality ingredients, determine food costs. and research and develop marketable new recipes and food concepts. Personal safety, food safety, and equipment safety will be emphasized.

Prerequisite: Fundamentals of Foods

#### HOSPITALITY FUNDAMENTALS

This course in the career field will introduce students to culinary arts, foodservice operations, lodging, travel and tourism. Students will obtain knowledge of customer service principles and examine the impact of cultural, historical, social and technological developments on key segments of the industry. They will also apply safety and sanitation techniques to prevent and control injuries, illnesses and diseases in the workplace. Business law, employability skills, leadership and communications will be addressed.

Prerequisite: Fundamentals of Foods

# SERVICE OPERATIONS & LEADERSHIP

Students will design and manage catering and banquet operations. They will recommend types of food functions and food-and-beverage services to clients, create menus for special occasions and events, and determine financial requirements. Students will hire, train, and supervise staff; manage event logistics, operations and service providers; and oversee dining room operations. Customer service; food, equipment and site safety; and high-volume food production will also be addressed.

Prerequisite: Fundamentals of Foods & Hospitality Fundamentals

6. The PE Department added weight training due to interest and made it, as well as Ref Prep, semester based courses so students may be able to have access to each content. Ref Prep incurs additional fees because of program certifications and uniforms and can be prohibitive because of the cost. The semester-based programming is to accommodate cost.

# **REF PREP**

The course will allow the students to explore concepts related to referring games of various competitions. Students will explore certification in this course. This course could incur a

significant number of fees as each license can be expensive in nature. These fees will be at the student's discretion.

\*\*\* Must be taken with another semester-based course. This course could be taken both fall and spring semesters if you choose. Each semester of the course requires fees for the assessments and a uniform fee.

#### WEIGHT TRAINING

The weightlifting class will provide each student with the knowledge needed to understand the importance of strength and fitness training. Students will understand the importance of setting goals for personal improvement and achievement. Students are encouraged to remain positive with themselves, as well as with other students in order to maintain a good training atmosphere, remembering that everyone progresses through this course at his or her own rate. Students will set goals for what they want out of their program (sport specific, toning, bulking, wt. loss, etc). Safety is always given the first priority in this class.

\*\*\* Must be taken with another semester-based course. This course could be taken both fall and spring semesters if you choose.

7. The Science Department added Ecology and Innovations in Science & Technology II to give additional elective science-based options to students.

#### **ECOLOGY & ECOSYSTEMS**

Ecology & Ecosystems is a course that focuses on understanding the physical, chemical, and biological processes that regulate terrestrial and aquatic ecosystems. During the course the class will discuss classic and current topics in ecology that have built our understanding of ecosystems organization and function. The course integrates disciplines of physiology, microbiological, population, and community ecology to understand how and why ecosystems differ in composition, structure, and function. The scope of the course includes examples from terrestrial, marine, and freshwater ecosystems.

**Prerequisite**: Must have taken Physical Science and had a "C" or better in either Biology or CP Biology

#### INNOVATIONS IN SCIENCE & TECHNOLOGY II

This course will take a deeper dive into the EDP. Students will focus on learning EDP specific terminology while applying it to a host of building projects. Students will also learn about the types of engineering in this course. This course will expand students' knowledge of CAD and 3D printing. The students will be heavily involved in the project designs for this course. This will function as an elective course.

**Prerequisite**: Innovations in Science & Technology I

8. The History Department added two CCP courses, as Mr. Fisher is already certified to teach CCP History, and we had an interest in the CCP coursework, as well as a number of students leaving campus to take the course at a higher rate at the Kent branch. This was an effort to

keep students on our campus, while offering the rigorous content. (Financial Literacy was added as a graduation requirement previously mentioned on this sheet.)

# CCP: WORLD CIVILIZATION I

This course provides an overview of human cultural development from earliest times to 1700. Emphasis will be on the musical, artistic, religious, and cultural achievements of these groups. Key individuals, societies, and historic developments will also be examined.

Prerequisite: Acceptance to Eastern Gateway Community College

#### CCP: WORLD CIVILIZATION II

This course provides an overview of human cultural development since 1500. Emphasis will be on the musical, artistic, religious, and cultural achievements of these groups. Key individuals, societies, and historic developments will also be examined.

**Prerequisite:** Acceptance to Eastern Gateway Community College

# 9. Mr. Cardaman changed all of the Spanish course descriptions to align to his curriculum,

#### **SPANISH I:**

The goal of this course is to begin developing communication skills in the Spanish language at the Beginner level and progressing towards the Novice Low range. Throughout the course, we will practice and develop both written and spoken communication methods in several areas - Interpersonal Communication, Presentational Communication, and Interpretive Communication. This will include various tasks that will require students to read, write, speak, and listen in Spanish through their developing knowledge of grammar, vocabulary, and cultural artifacts.

Prerequisite: "C" or better average in English

# **SPANISH II:**

The goal of this course is to continue developing the communication skills begun during the previous course. This level develops the students' breadth of knowledge in the Novice Low range,

seeking to progress to a more advanced level. The same communication methods are used to develop communication skills in diverse contexts.

Prerequisite: "C" or better average in Spanish I is recommended

#### **SPANISH III:**

The goal of this course is to develop the communication skills from previous classes as well as the knowledge of vocabulary, grammar, and culture to develop a higher level of mastery in the Spanish language - progressing towards the Novice Mid range, or higher. Students will explore various contexts of communication, completing different communicative tasks.

Prerequisite: "C" or better average in Spanish II is recommended

#### **SPANISH IV:**

The goal of this course is to use all previous knowledge to develop, seeking to achieve a Novice Mid to Novice High range of language proficiency. The course will require a mastery of all previous skills and knowledge and will have students seek to use the Spanish language to communicate as much as possible throughout the course, only returning to English and communication in Spanish is no longer possible for the sake of learning.

Prerequisite: "C" or better average in Spanish III is recommended
