  - During conference periods, at scheduled parent-teacher conferences and at other times that are scheduled through the school office.
  
5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows:
  - Parents are always welcome at the school throughout the year and are encouraged to volunteer in their child's classroom, in the media center, and/or other classrooms and are provided instruction on how to access the varied opportunities and the procedures once they are there.
