Frankfort Community Unit School Dist # 168 is currently accepting Annual Bakery Bids for the 2022-2023 school year.

Please note the following requirements for the Frankfort Community Unit School Dist. # 168 annual Bakery Bid process for 2022-2023:

- All bids accepted must be firm for the 2022-23 school year (August 1, 2022-June 30, 2023). Changes to bid pricing will not be accepted during the school year with the exception of force majeure. If Force Majeure is enacted during the 2022-23 school year, a formal letter must be received by the Frankfort CUSD # 168 at least 60 days prior to the change in cost.
- A minimum delivery of 2 days per week per school district location is required unless otherwise agreed upon with Distributor and Frankfort Community Unit School Dist # 168.
- All bidding companies must submit the attached Bid Worksheet for all products requested. For items not listed, please attach additional items and coordinating bid pricing to final bid returned.
- All stock must be rotated upon delivery.
- All vendors must provide bakery racks for each school district location at no charge.
- All bidding companies must be able to deliver specific product to all district locations. If your company is able to serve all sites participating and several bakery facilities are required for delivery, please bid one price for all locations, regardless of delivery origination.
- All products bid must be Peanut Free and include either a Peanut Free Statement letter or notice on package.
- To receive credit in the new USDA Final Rule, All Bakery Products must contain at least 51% whole grains and the remaining grain content of the product must be enriched. Whole Grain or Whole Wheat Flour **MUST BE THE FIRST INGREDIENT**. The Whole Grains per serving (minimum 1 oz. contribution) must be greater than or equal to 8 grams.

Formal, sealed bids must be received and will be opened by the Frankfort Community Unit School Dist # 168 no later than 10:00am on Thursday, June 23, 2022. Sealed bids should be mailed or delivered to the following address:
