# Frankfort Community Unit School District #168 BOARD OF EDUCATION REGULAR MEETING

#### Monday, June 27, 2022 – 6:00 pm

The Board of Education of Frankfort Community Unit School District #168 held a Regular Board Meeting on Monday, June 27, 2022, at 6:00 p.m. in the Central Junior High School Library, 1600 East Ninth Street, West Frankfort, Illinois.

I. Call to Order, Roll Call, and Establishment of Quorum: President Keith Griffith called the Regular Meeting of the Frankfort Community Unit School District #168 to order at 6:00 p.m. with the following members physically present: Jon Alexander, Dawn Browning, Rick Conner, Keith Griffith, Clint Hawkins, and Kevin Toney. Board member Larry Burns attended the meeting remotely.

Nine other people were present including the Superintendent, the Recording Secretary, two administrators and directors, a staff member, and four members of the public and vendors.

- II. Hearing of Delegates or Visitors and Public Comments: Ms. Schannone Steinberger asked for an update on a previous question and Mr. David Summers, a custodian at FCHS, expressed some concerns about school safety.
- III. Approval of Minutes The Open and Closed Sessions of the May 16, 2022, Regular Meeting: Mr. Alexander made a motion to approve the minutes of the Open and Closed Sessions of the May 16, 2022, Regular Meeting. Mr. Toney seconded the motion. The motion carried 7-0.
- IV. Approval of Bills and Financial Reports: Mrs. Browning made a motion to approve the bills in the amount of \$1,090,792.26 and financial reports presented, including two payrolls in the month of May, 2022 in the amount of \$946,340.98. Mr. Griffith seconded the motion. The motion carried 7-0.

Superintendent: The Superintendent's report included 1) information that Property and Liability Insurance rates had improved because of the continuing drop in Worker's Compensation claims as well as 2) a summary regarding Public Act 102-0522 after a recent social media post from a northern Illinois-based entity regarding the District's plans had local residents concerned (this Public Act was the change the state made last year in the comprehensive health education program regarding sex education – the District is still waiting for the Illinois State Board of Education to release learning standards to determine if there is any middle ground between full implementation versus no sex education at all at any level – at this point, the District continues to wait while noting that it has no plans to implement the full comprehensive sex education curriculum).

Mr. Conner seconded the motion. The motion carried 7-0.
