Frankfort Community Unit School District #168 BOARD OF EDUCATION SPECIAL MEETING

Wednesday, October 26, 2022 – 6:00 pm

The Board of Education of Frankfort Community Unit School District #168 held a Special Board Meeting on Wednesday, October 26, 2022, at 6:00 p.m. in the Central Junior High School Library, 1600 East Ninth Street, West Frankfort, Illinois.

A. Call to Order, Roll Call, and Establishment of Quorum: Vice-President Clint Hawkins called the Special Meeting of the Frankfort Community Unit School District #168 to order with the following members present: Jon Alexander, Dawn Browning, Larry Burns, Rick Conner, Clint Hawkins, and Kevin Toney. Mr. Keith Griffith was absent. The purpose of the Special Meeting was to hold hearings regarding student disciplinary cases.

Approximately 225 other people were present including the Superintendent, the Assistant Superintendent, six administrators and directors, members of staff and members of the public from within and outside the school district.

B. C. New Business:

 - 2. Logan College, and hereby directed the Superintendent to issue a written decision consistent with the Board's decision. Mr. Conner seconded the Motion. The Motion carried 6-0.
