Further that public notice of a hearing on the closing of the Wilson attendance building for grades 7th through 12th be given in accordance with K.S.A. 72-1431, setting the date of the hearing for Nov. 28, 2022, at 6:00 p.m. with the hearing being held in the Commons Area at the USD No. 112 Wilson Schools in Wilson, Kansas, located at 2005 Ave. D., Wilson, Kansas, and that the reasons for the proposed closing be given as follow:

- 1. The financial condition of the District.
- 2. The District's need to reduce expenses
- 3. The District's need to gain those efficiencies which can be gained by closing a building
