Mr. Clark conducted the budget hearing for the 2018-2019 school year. He reviewed the district's assessed valuation by county and the mill levies for the general fund, local option budget, and capital outlay funds. Overall, the mill levy decreased by .513 mills over last year. He also reviewed the Notice of Hearing (Code 99), form 150, which calculates or computes the General Fund, and form 155, which calculates the Supplemental General Fund or Local Option Budget.

On motion by Tony Zink and seconded by Brad Schiermeyer, the board voted 7-0 to approve the budget as presented for the 2018-2019 school year.

Building reports, given by the administrators, were as follows:

Jane Oeser presented the latest enrollment numbers for CPES-Holyrood with 149 students, which is up 1 student and CPMS —Bushton, with 92 students, which is up 8 students from the end of last year. She also discussed Pathways to Reading and MTSS training; back-to-school inservice activities for staff and also students; football and volleyball practices have started; and upcoming orientations.

Kenroy Wilson presented the current enrollment figures for Wilson Elementary, grades Pre-school through 6th, at 109 students and Wilson Jr-Sr High School, grades 7-12 at 60 students for a total of 169 students. This is down 5 students from the end of last year. He also reported on the fall sports practices; Meet-n-Greet for students and staff; Baptist Church sponsored luncheon; and other back-to-school inservice activities for staff.

Toby Holmes presented the current enrollment figures at CPHS-Claflin, with 83 students enrolled, and 1 or 2 students that may still enroll. He also reported the gym floor is completed; MTSS training; St. Paul Methodist Church breakfast; back-to-school inservice activities for teachers, students and parent orientation; and practices have begun for all fall sports.

By consensus, the following board members will serve on the Hall of Fame committee for the upcoming year: Tony Zink, Michelle Brokes, and Cherlyn Maier.
