The board opened discussion on the Wilson 7-12 attendance building. Topics included the following: bridge repairs south of Wilson with possible delays for bus routes; delay closing the building; share teachers with the Diocese including Art, PE and Music, along with utility costs; quality of education and shortage of teachers; selling the entire building to the Diocese or the 7-12 side; possibly leasing the building to the Diocese and the timeframe to complete the lease.

On motion by Brad Schiermeyer and seconded by Roger Robinson, the board voted 6-1 to negotiate a lease agreement between USD 112 and the Catholic Diocese of Salina for the use of the 7-12 building at Wilson for the 2023-2024 school year for the board to review. Tamara Dody voted no.
