President Tamara Dody called the meeting to order.

On motion by Dalton Wirth and seconded by Chad Rogers, the board voted 5-0 to approve the agenda.

On motion by Chad Rogers and seconded by Josh Hurley, the board voted 4-0-1 to approve the minutes of the June 12, 2023 meeting. Brad Schiermeyer abstained.

On motion by Chad Rogers and seconded by Josh Hurley, the board voted 5-0 to approve all invoices presented, in the amount of \$174,363.01.

Mr. Lowry, along with Diane Ney reviewed with the board the remaining cash balances in various funds and the recommended year-end transfers. They discussed the budget reduction to the general fund, after republication, due to the state audit on virtual fund credits for those 20 and older.

On motion by Josh Hurley and seconded by Chad Rogers, the board voted 5-0 to approve the year-end transfers as presented and allow the superintendent and board clerk to make any final adjustments to close the budget.

Fund 15 – Virtual Education - \$25,000

Fund 26 – Professional Development - \$3,000

Fund 30 – Special Education - \$60,000

Fund 34 – Vocational Education (CTE) - \$11,000

Fund 55 - Textbook Fund - \$35,000

Mr. Lowry reviewed the renewal premium rates for the district's health insurance plan, which will go into effect Oct. 1, 2023. The average, overall increase was 8.77%.

On motion by Chad Rogers and seconded by Josh Hurley, the board voted 5-0 to approve the district-paid health insurance benefit of \$535 per month, effective Oct. 1, 2023.

On motion by Josh Hurley and seconded by Dalton Wirth, the board voted 5-0 to approve the classified handbook as presented, for the 2023-2024 school year.

On motion by Chad Rogers and seconded by Josh Hurley, the board voted 5-0 to appoint Amanda (Mandi) Griffin as the authorized representative for Food Service, beginning July 1, 2023
