With coordination from the Interlocal, the state has been contacted about getting a team from TASN to come and assist with this process.

b. ALICE Training for Officer Strong

Cory Strong, SRO, will be attending an ALICE training in Strong City the last week of December. This training will certify him to be an ALICE instructor. With this certification he will then be able to train the district staff.

OLD BUSINESS

a. Pickleball/Tennis Court Update

Mike Dixon came to visit about his idea of resurfacing the current courts with a track-like material that he has patented. He guarantees its durability and anticipates it will hold up for between 8-10 years. He brought samples of the resurfacing product for the board to look at. Still waiting on other bids to be submitted for this project before making a recommendation to the board.
