CALL TO ORDER

President Polhlopek opened the meeting at 6:00 p.m. The Pledge of Allegiance was recited, and then President Polhlopek shared the district mission statement. There were no public comments.

 - Governor Kelly has been sending multiple letters to constituents in regard to her initiatives to "axe the tax" campaign.
 - Made a visit to the Kansas State Capital on December 13th with the Greenbush Leadership Team. The visit was a great experience to learn about how to present to the house to be in favor or not in favor of suggested bills.
 - Information from KASB was received regarding the board policies and what the next steps are to get them in place and posted.
 - The freezer at the elementary school went down. The refrigeration unit needs to be replaced. The unit was ordered from Joe Harding at an estimated cost of \$12,090.
 - An administrator meeting was held on January 5th and the following items were discussed:
 - Went through feedback from the January 2nd PLC from teachers to guide future professional development and focus.
 - Schedule ideas for next year to promote more professional development opportunities and increase teaching leaders capacities.

a. DCS Services Updates

Chad Marlow, from DCS services, discussed with Dr. Streeter some additional inspections for soil through GEO Tech Service that needed to be done. There is also an additional cost to getting soil samples and other prep services that was shared with the board. This cost was left out of the original bid.
