The South Heart Public School has a highly qualified staff engaged in teaching a curriculum that follows state standards and benchmarks. The Title I Department gives all students appropriate support and assistance in targeted areas that are in compliance with the Federal guidelines and mandates. Staff is provided with opportunities for training each year that promotes professional growth.

Parent-teacher conferences will be held twice a year, once in September and again in January.

The South Heart Public School will provide parents with mid-term reports quarterly. Parents will also receive report cards quarterly. First and third mid-quarter reports will be picked up at the school at conference time. Second and fourth quarter report cards as well as midterm grades will be provided. 4. Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as follows:

#### Staff is available for parent consultation before and after school, by appointment and at parent-teacher conference time. Parents are also welcome to communicate with staff by telephone or email or through appropriate class apps.

5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows.

Parents are given many opportunities to volunteer, participate, and observe their child. Individual teachers ask for volunteers on an as needed basis. Parents may participate during the year by chaperoning for in-school events and field trips, attending open houses, school plays, and concerts. Classroom observation is available year round with advance notice.

6. Ensure regular two-way, meaningful communication between family members and staff, in a language that family members can understand.

If parents inform us of a language barrier through home language form, we will provide communication and information to bridge the language barrier in all areas of communication; phone calls, emails, paperwork, progress reports, conferences, etc.

# \* <u>Parent Responsibilities</u>

We, as parents, will support our children's learning in the following ways:

- Monitoring attendance.
- Making sure that homework is completed.
- Monitoring the amount of television my child watches.
- Volunteering in my child's classroom.
- Participating, as appropriate, in decisions relating to my children's education.
- Promoting positive use of my child's extracurricular time.
- Staying informed about my child's education and communicating with the school by promptly reading all notices from the school or the school district either received by my child or by mail and responding, as appropriate.
- Serving, to the extent possible, on policy advisory groups, the Title I Policy Advisory Committee, or other school advisory or policy groups.

Through Federal Education law, parents have the right to request information on the professional qualifications of the teachers and paraprofessionals at our school. Upon this request, you will receive a detailed explanation of the licensing, education and experience of each of our teachers. You will also receive information regarding the names and qualifications of the paraprofessionals at our school.

At any time during the school year, parents will be notified if a child is assigned, or taught by, a teacher who is not highly qualified for four or more consecutive weeks.

Each parent or guardian will be furnished information on the level of achievement of the parent's/guardian's child in each of the state academic assessments required by the law.

# DISTRICT PARENT AND FAMILY ENGAGEMENT POLICY
