Ms. Tilford presented documentation for a Lease Purchase option from LJ Hart and Company for the next phase of the Sports Complex using a 7 or a 10-year finance option. Each cash flow page shows what would need to be allocated from either CRT and/or the 7% transfer to cover the payments. The lease would produce funds of \$883,000 to be used to pay for the cost to Veregy.

Prior to approving the lease, LJ Hart will send us the Notice that will be placed in the paper. It would be run for two consecutive weeks, the last posting would be at least 7 days prior to the regular board meeting (December 15, 2022) or a special board meeting to approve the resolution.

Typically, once approved it is about two weeks for it to close and the district would have money in a construction account at the Paying Agent bank. Much like bond proceeds, you just send the bank a payment document and they would pay Veregy.
