April 2023 Board Meeting Summary



Highlights of Reports and Discussion Items

The following items were presented to the board:

Student Recognition – Three students were recognized by the board of education for their outstanding placements. Madison Cummings (Drawing & Illustration) and Emma Lane (Ceramic & Glass) earned gold medal placements in the National Scholastic Art and Writing Awards. Tessa Spatafore placed first overall in IHSA state as the Critic Choice Award Winner for her short film, "Outside". Congratulations!

Enrollment Report – The current enrollment as of March 1, 2023 is 1,438 students.

Principal's Report – Karen Stevens presented data that shows that students are once again succeeding at pre-COVID levels.

Financial Report – Dr. Beverlin presented the investment and insurance report, which shows investments of approximately \$7.6 M, as well as insurance costs through March 31, 2023. The insurance fund has exceeded the break-even amount, but the stop loss payment process is helping to cover some of these expenses. Board Committee Reports

Curriculum <u>March 27</u> and <u>March 29</u>: The committee reviewed the department goals over two meetings and long range planning for retirements.

Extracurricular Employment: The Board of Education approved the employment of Paloma Simundic, Assistant Volleyball Coach.

Retirement: The Board of Education approved the intent to retire for L. Kinsinger, Study Lab Coordinator & International Club Sponsor.

Intergovernmental Agreement with Tazewell County

EFE – The Board of Education approved the intergovernmental agreement that includes the details of the cooperative we participate in for Education for Employment (EFE) classes such as welding, business, childcare, foods, etc.

Summer Maintenance – The Board of Education approved the list of summer maintenance employees and the summer 2023 maintenance plan.

Torry Gym – The Board of Education approved the bid for <u>Torry Gym exterior improvements</u> from the lowest responsible bidder Illinois Civil Contractors in the amount of \$150,000.

Ashbrook Roof – The Board of Education approved the base bid contract to Kreiling for the <u>Ashbrook</u> Roof Recovering project to the lowest responsible bidder in the amount of \$367.010.
