D. Athletics Update (INFORM/DISCUSSION)

We will have wrestling, basketball, spiritline (coaching will be Mrs. Coles. We will also have cross country, tennis, golf and

esports. Registration for sports is online. We are looking into having a physical night in the summer for students.

E. Mavs Win Pledge (ACTION)

If an athlete commits a crime outside of school, they are currently not held back from playing sports. This would hold the students accountable to a higher standard to play sports. For example, tobacco, nicotine, alcohol, etc., in and out of school. Anything they do can be congruent to sports.
