BOARD APPROVES THE PURCHASE OF 1,000 ADDITIONAL DELL CHROMEBOOKS

The Board approved the purchase of an additional 1,000 chromebooks and Sigmanet Managed Services for our 1 to 1 student initiative.

Growth in the 2014-2015 school year was greater than expected, depleting the reserve stock of 500 devices. Additional devices are needed to ensure that every student in grades 2-12 has a device as well as provide reserve stock.
