### **FRICK, FRICK & JETTE, ARCHITECT CONTRACT APPROVED FOR WORK AT HESPERIA HIGH SCHOOL**

The Governing Board authorized staff to execute a contract between Frick Frick & Jette and the District to provide design documents for upgrades to the gymnasium and cafeteria at Hesperia High School. Twelve percent of construction costs are to be paid through CFD 2006-5.

The renovations are planned for summer of 2016 and will include:

- Window coverings
