GOVERNING BOARD COMPLETES MASTERS IN GOVERNANCE CERTIFICATE PROGRAM



Board members Swanson, Childs and Kittinger recently completed the California School Boards Masters in Governance Program. This certificate recognizes a demonstrated commitment to learning, leadership and effective governance. BOARD AWARDS RFP FOR NEW STUDENT INFORMATION SYSTEM

Early this year, Pearson Education announced its intention to discontinue support of PowerSchool, our current student information system (SIS). HUSD subsequently advertised Request for Proposals (RFP) #16-102 for a Student Information System. After meeting with a selection committee comprised of 32 stakeholders representing various groups of SIS users, a recommendation was made to the Board by staff to award RFP #16-102 Student Information System to Infinite Campus.

The goal is to have the new student information system implemented in the following school year.
