NATIONAL BOARD CERTIFICATION:

In each year that an employee receives a bonus from the State Board of Education for holding national certification, the employee shall be paid an additional \$2,500 from county funds.

LOCAL SHARE INFORMATION:

Under a December 15, 2008, county board resolution, an additional local share supplement of \$700 is annually, near November 30, paid to each employee (and prorated for employees whose annual contract term exceeds 200 days), but this additional payment must be discontinued if, in any school year, the local share funding for the additional pay is no longer available for any reason. With the passage of the FY '20,21,22,23 & 24 excess levy the rate increased to \$1,150. The rate further increased by \$50 in FY '22 to a total of \$1,200 to provide for an increase in vision examinations.
