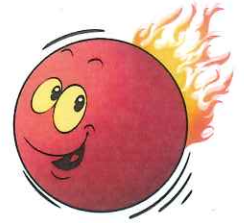


# Give Back-Kick Back Co-Ed Kickball Tournament (Minor Release)
