  Authorize the purchase, operation and maintenance of transportation vehicles

  Fix salaries and reimbursement of each district officer: current rates are \$800 per Board member, \$25 per special meeting, up to \$175 for travel and reimbursement expenses for performance of duties.
- 9. Resolution D Disposal of Surplus Property
  BE IT RESOLVED by the board of Sharon Joint School District #11, is hereby
  authorized, during the current school year, to sell and dispose of any tangible
  personal property belonging to the school district that is determined by the school
  board to be no longer needed for school purposes, provided, however, that the
  maximum aggregate value of such tangible personal property disposed of during
  the school year shall not exceed \$1,000.00 value as evidenced by an
  independent appraisal and/or competitive bids.

  Direct the school board to furnish school lunches/breakfasts to the pupils of the district and appropriate funds for that purpose.

   Authorize the school board to furnish textbooks.
