

# Christopher P. Taft Scholarship

## 2023 Application

Application Deadline: February 28, 2023

The Preferred Foundation is a corporate giving entity of **Preferred Mutual Insurance Company** located in New Berlin, New York. The Christopher P. Taft Scholarship will award one college scholarship. The candidate receiving the highest rating will receive \$1,500 each year for up to four (4) years. Selection is based on careful review of the application, required materials documenting academic performance and activities, and a personal interview.

### WHO IS ELIGIBLE?

Current high school seniors meeting the following criteria are eligible:

- Planning to attend an accredited college/university in the fall following their high school graduation; *and*
  - Reside in NY Counties of Otsego, Delaware or Chenango; *and*
  - Have a high school academic standing (GPA) of 95.0 or higher.
  - Pursuing a degree in Accounting/Business
- or*
- Are the children of non-officer Preferred Mutual employee, and have a high school academic standing of 95.0 or higher.

### WHAT CAN THE SCHOLARSHIP BE USED FOR?

The scholarship may be used to pay tuition, college room and board, and other college fees. The award recipient must be enrolled as a full-time undergraduate student in a college or university in the United States that holds accredited higher education status. The scholarship is not payable for attendance at service academies, virtual universities or certain institutions limited in their purpose or training. The recipient must be enrolled in a course of study leading to one of the traditional baccalaureate degrees and remain in good academic and disciplinary standing. Disbursement will be made upon receipt of bills due or proof of payment made. Funds will be released to the appropriate party.
