Subject: Approval, Commission on Teacher Credentialing Variable Term Waiver Requests and Provisional Internship Permits, 2022-2023

The Shandon Joint Unified School District anticipates the need for additional certificated coverage during the 2022-2023 academic year.

The California Commission on Teacher Credentialing ("CCTC") is, among other areas, the authority for educator preparation for the public schools of California, and for licensing and credentialing of professional educators in the State. It expressly has the authority to issue variable term waivers and provisional internship permits when a fully credentialed teacher is not available for an assignment, and provides districts with the ability to employ or assign persons who are not appropriately credentialed for a given assignment while searching for a fully credentialed teacher in the subject area of the assignment.

Waivers and provisional internship permits are issued or denied based upon the Commission's established criteria and factors such as an employer's continuing needs; the support the employer will provide to the applicant; or extenuating, extraordinary and unanticipated circumstances. Declaring a shortage of certificated substitutes with an authorization to teach in low and high incidence areas including, but not limited to, special education, mathematics, and science is required of the Lucia Mar Unified School District in order to apply for a variable term waiver or provisional internship permit.

Similarly, declaring a shortage of substitutes is required for the Shandon Joint Unified School District to apply for a variable term waiver for the 30-Day Substitute Basic Skills Requirement. Education Code 44252(b) requires that a 30 Day Emergency Substitute Teaching Permit (Sub Permit) only be issued after the applicant has demonstrated proficiency in basic reading, writing, and mathematics skills. This is referred to as "Basic Skills." Basic Skills are most often met via a passing score on the California Exam for Basic Skills Test ("CBEST") or through a basic skills evaluation. Due to the shortage of workers, the Shandon Joint Unified School District has been unable to actively recruit enough certificated substitutes who have met the basic skills requirement.
