- a. Approval of FFA Overnight Stay for P2C Conference in GI, November 4-5. FFA is requesting the Board allow an overnight stay for P2C Conference in GI.

- b. Decision to Allow or Not Allow Spectators on the track during Football Games. There have been many questions about whether football spectators will still be able to walk on the track to be "close" to the games. With most schools that have put in a new track the district does not allow spectators onto the track during football games and many of them do not allow any spectators inside during track meets either (though there are a few that do for some meets).

The majority of schools that allow spectators "near the field" for football games do not have a track so there is no concern about spectators.

This is a Board decision that probably should be decided before the first football game on October 21.

Options:

- The Board says no one on the track starting right away.
- The Board says everyone can be on the track for football games.
- The Board could to let people on for this first game, so they "feel" the track, and then not allow this for future years.
 - o I am not sure this is a very good option.

We will always have a walk thru gate that people can access the track when they are walking for "health". We would not want strollers, bikes, or pets on the track ever.

During track, people will be able to access the shot put and discus area but not the rest of the track. This is so those running the events can do so without parents/others in the way. At District Track no spectators can be inside.
