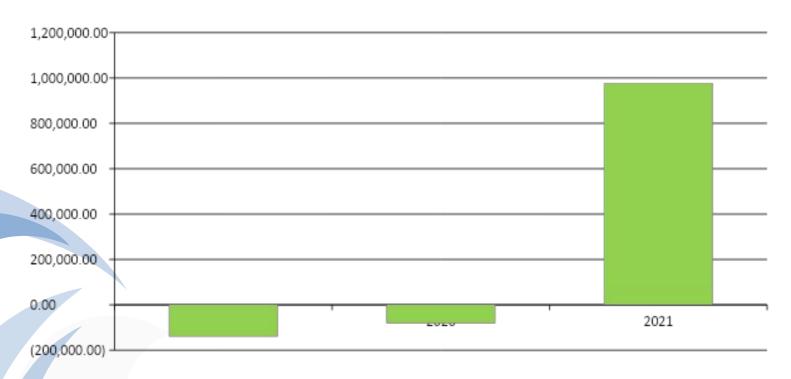

#### **Observations:**

- Intergovernmental revenues were below projections primarily due to reduced State Subsidy.
- Other revenues are comprised of several smaller amounts that are less predictable from year-to-year and the RSU budgeted conservatively due to this unpredictability.
- Transfers in are from several other smaller funds which were closed and consolidated into the general fund in 2021.

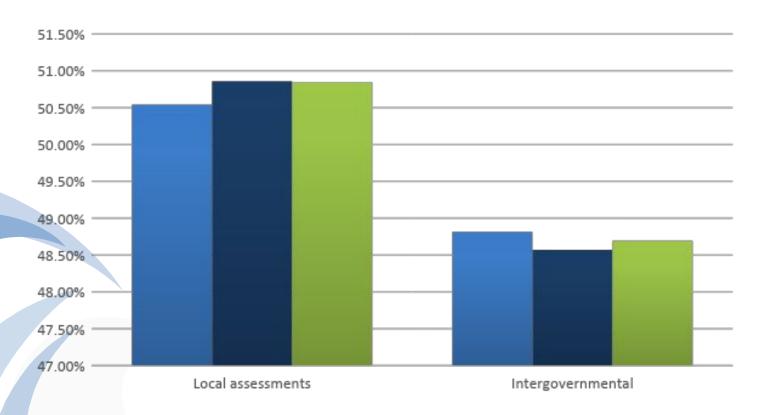

#### Observations:

- Regular instruction and special education realized savings mostly due to reductions in tuition costs.
- Student and staff support was under budget primarily due to savings in personnel expense.
- Transportation realized some savings due to a reduction in service and savings realized from a reduced workforce.
- Facilities maintenance realized savings as certain repairs and other equipment purchases were delayed or funded via grant funds.

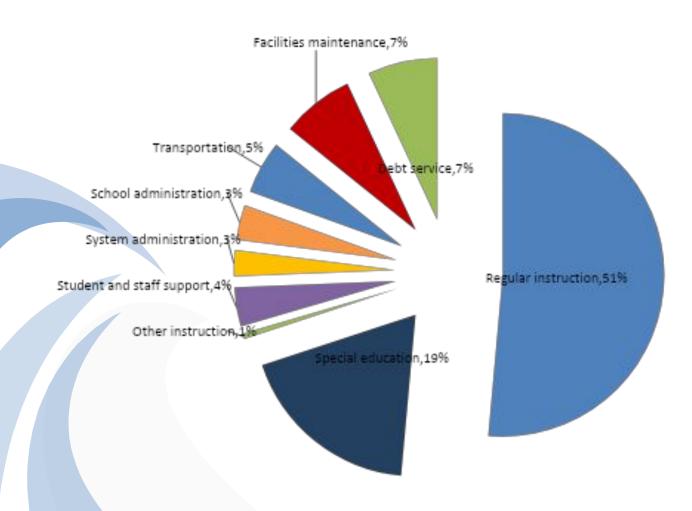


### GENERAL FUND - REVENUE DISTRIBUTION

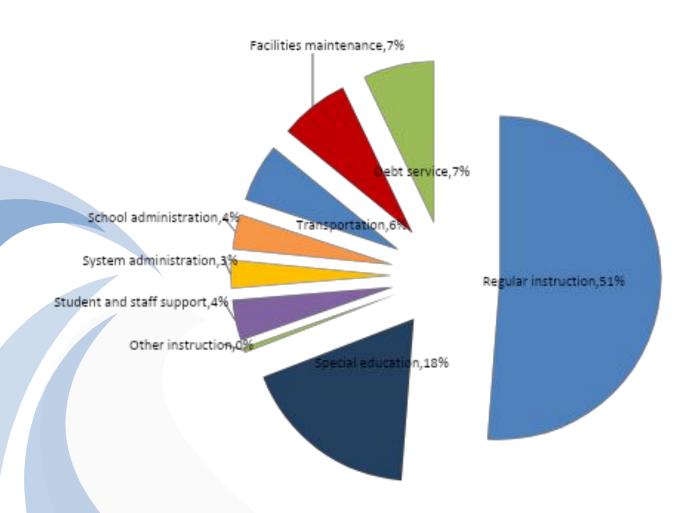




### **GENERAL FUND - EXPENDITURE DISTRIBUTION - 2021**
