Meridian 2017-2018 Final Audit

Superintendent Carmoney stated that the Finance Committee met with Bill Hirschman, Senior Auditor of Roslund, Prestage and Company before the Board meeting to go through the Financial Statements and Supplemental information in detail and everything is in order. He stated that our Director of Business Services, Sarah Glann, does a great job with our district finances. Sarah stated that the 2017-2018 Final Audit shows that the district has an unassigned Fund Balance of approximately 15% which is a very healthy range and she also stated that our Food Service program was selected for the Single Audit of a Major Federal program and everything was in order with this program as well.

Announcements/Communications from Board Members or Superintendent

Superintendent Carmoney stated that he has a few items to share with the Board; he stated that 2 of the items have to do with the November election coming up. He wanted to remind the Board members that the School Resource Officer Proposal will be on the ballot and he shared the pamphlet that Midland County had created on the facts of this proposal. Superintendent Carmoney also shared some alarming facts on the hot issue of the Legalization of Marijuana and stated that marijuana today with its higher THC levels is not the same as the marijuana from 30-40 years ago, especially with the edible forms that are out there today. Lastly, Superintendent Carmoney shared a Threat Assessment Document that the Clare-Gladwin RESD prepared and we have adopted as an Administration team to assist us when dealing with threats in our schools. He stated that it is hard to balance communication with doing our jobs and not create more panic.
