WHEREAS, the Board has prepared an Amendment to the original Employment Agreement between the Superintendent and the Board of Education, with such Amendment modifying the rate of compensation for the 2022-23 school year so that it will increase by 2.0% to a total of \$132,926, and including a provision that provides for a payment of unused earned sick leave upon the Superintendent's departure from the District; and,

WHEREAS, the Board and the Superintendent agree to such proposed Amendment.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education hereby accepts and agrees to the Amendment to the Agreement, dated April 26, 2022 (as attached herewith), and hereby authorizes the President of the Board, or the Vice President in his absence, to execute said Agreement on behalf of the District and to file same with the District Clerk.
