The District reserves the right to reject any or all bids and to waive informalities and minor irregularities in bids received, and to accept any or all portions of a bid is deemed to be in the best interest of the District. The Invitation to Bid implies no obligation on the part of the District, and the District's silence does not imply any acceptance or rejection of any bid or quotation offer. The District reserves the right to select a bid with higher prices than the lowest of all prices received if, in the District's opinion, interests will be best served by such bid. Raymore-Peculiar School District shall be the sole judge in determining successful bidder(s) in regard to quality, price, and performance.

**GENERAL INFO:**

Purpose of Bid: The Raymore-Peculiar School District desires to solicit bids to contract with a vendor to deliver tanker loads of approximately 135,000 gallons of Diesel fuel, and approximately 25,000 gallons of unleaded on an “as needed” basis. The loads will have to be pumped as this is an above ground tank.

For bid purposes, bidders will indicate a markup per gallon by fuel type to be added to the OPIS published Low price for the Kansas City Area Wholesale Suppliers. The District is exempt from Federal Fuel Taxes, do not include them in this bid. Note: The District will pay the most recent OPIS published low price for the fuel received plus the listed mark-up per gallon.

The successful bidder will be required to meet the following:

- All ULSD fuel must meet the following minimum specifications:

- Gasoline must meet the minimum rating of 87 octane, be 7.0 or 9.0 RVP by law depending on time of year, and may be up to 10% ethanol, if it is cheaper than standard unleaded at time of purchase. Must have detergent additives.

Fuel deliveries will be made on an “as needed” basis to 19620 Harrelson Dr, Belton MO, 64012. Vendors will be notified of the need for delivery by 5pm and fuel must be delivered within 48 hours.
