1. **ACCURACY OF BID** – Each bid is publicly opened and is made part of the public record of the Raymore-Peculiar School District. Therefore, it is necessary that any and all information presented is accurate.
2. **SUBMISSION OF BID** – Bid is to be sealed and submitted to The Raymore-Peculiar School District, Attn: Pam Steele, Board Secretary, 21005 S. School Rd, Peculiar, MO 64078, prior to the date and time indicated above.
3. **LATE BIDS AND MODIFICATIONS & WITHDRAWALS** – Bids received after the deadline designated in this bid document shall not be considered.
4. **NEW SUPPLIES**– Unless otherwise specified, all material or supplies offered shall be new, unused, of recent manufacture, and suitable for their intended purpose.
5. **DELIVERY TERMS** – F.O.B. delivery to stated location within defined times, to be determined upon order of equipment.
6. **DAMAGED AND/OR LATE SHIPMENTS** – The Raymore-Peculiar School District has no obligation to accept damaged shipments and reserves the right to return at the vendor's expense damaged merchandise even though the damage was not apparent or discovered until after the receipt of the items.
