WHEREAS, based on the recommendation of the District's Architect, LaBella Associates, the Board of Education of the Rome City School District (the "Board of Education") has determined that it is in the best interest of the Rome City School District (the "School District") to accept a proposal from Kelley Bros dated November 5, 2021, revised February 18, 2022 (Project # 6-2143604-2) (the "Proposal"), to provide the goods and services described therein in connection with its 2019 Capital Improvement Project – Phase II (the "Project"); and

WHEREAS, the total amount of the cost of the Proposal is \$931,556.84;

WHEREAS, the Proposal has been submitted under the authority of the Kelley Bros Jefferson County contract under BID #2019B-5 Doors and Frames as an exception to competitive bidding contained in NYS General Municipal Law §103(16) and in compliance with the Board's procurement policies #4500 and #4502;

WHEREAS, the Board of Education hereby accepts the recommendation of the District's Architect and hereby accepts the Proposal shared with the Board;

NOW, THEREFORE, be it resolved as follows:

- The Board of Education accepts the recommendation of the District's Architect, hereby accepts the Proposal, and authorizes the President of the Board, the Superintendent of Schools, or their designee to enter into one or more contracts or issue Purchase Order(s) on behalf of the Board of Education and take all actions necessary or convenient to proceed under the contract(s) or Purchase Order(s) in connection with the Proposal and the Project.
- 2. Upon Board of Education approval, this resolution shall take effect immediately.
