1. Resolution to Transfer Moneys to Capital Reserve Plan:

WHEREAS, on December 18, 2019, Rome City School District (the “School District”) voters passed a proposition to establish a capital reserve fund pursuant to Section 3651 of the Education Law (the “2019 Capital Reserve Fund”); and

WHEREAS, Education Law Section 3653 requires that no monies may be paid or transferred into any reserve fund established by a school district unless expressly authorized by a resolution of its board of education; and

WHEREAS, it has been determined by the Board of Education of the School District that up to \$5,000,000 held in budgetary appropriation are surplus funds, and that it is in the School District’s best interest to transfer moneys to the School District’s 2019 Capital Reserve Fund. NOW, THEREFORE, BE IT

RESOLVED; that the Board of Education of the School District does hereby approve the transfer of up to \$5,000,000 from budgetary appropriation or such revenues as are not required by law to be paid into any other fund or account to the 2019 Capital Reserve Fund created in accordance with Section 3651 of the Education Law. This Resolution shall take effect immediately.

2. Resolution to accept the Comptroller’s Audit Corrective Action Plan:

RESOLVED: That upon review of the District Audit Committee and the recommendation of the Superintendent of Schools, the Board approve the corrective action plan in response to the Comptroller’s audit # 2021M-144.

WHEREAS, the Project Architect and the involved contractors will prepare, sign, and submit proposed Change Orders (“Change Order”) for the following work:

WHEREAS, the Board of Education has determined that it is in the best interest of the School District to approve the proposed changes and accept the proposed Change Orders;

NOW, THEREFORE, be it resolved as follows:

1. The Board of Education approves the changes set out in this resolution.
2. The Board of Education hereby authorizes the President of the Board to sign the Change Orders on behalf of the Board of Education and take all actions necessary or convenient to proceed under the Contracts as amended by the Change Orders in connection with the Project.
3. The Board of Education hereby authorizes the Superintendent of Schools to sign the New York State Education Department required certification in connection with each Change Order and take all actions necessary or convenient to satisfy applicable Change Order certification and filing requirements.
4. Upon Board of Education approval, this resolution shall take effect immediately.

MISCELLANEOUS BUSINESS

1. Resolution to approve sale of District property:

WHEREAS, the Rome City School District (the “School District”) is the owner of real property located at 110-112 West Linden Street in the City of Rome, County of Oneida, State of New York, identified as Tax Map No. 223.020-6-22 (the “Property”); and

WHEREAS, the voters of the District, on May 19, 2020, authorized the sale of the Property at the price of Five Hundred Twenty-Five Thousand Dollars (\$525,000) in accordance with Education Law §2511(i) and §2512(5); and

WHEREAS, Board has considered an Agreement of Purchase and Sale proposed by Bowers Development LLC and seeks to approve the same.

RESOLVED, by the Board of Education of the Rome City School District, as follows:

1. The Board approves the Agreement of Purchase and Sale proposed by Bowers Development to purchase property at the price of Five Hundred Twenty Five Thousand Dollars (\$525,000) upon the terms and conditions set forth in the purchase contract.
2. The Superintendent or his designee are authorized and directed to take all steps necessary or appropriate to complete the transaction contemplated herein.
