WHEREAS, it has been determined by the Board of Education of the School District that up to \$5,000,000 held in budgetary appropriation are surplus funds, and that it is in the School District's best interest to transfer moneys to the School District's 2019 Capital Reserve Fund. NOW, THEREFORE, BE IT

RESOLVED; that the Board of Education of the School District does hereby approve the transfer of up to \$5,000,000 from budgetary appropriation or such revenues as are not required by law to be paid into any other fund or account to the 2019 Capital Reserve Fund created in accordance with Section 3651 of the Education Law. This Resolution shall take effect immediately.
