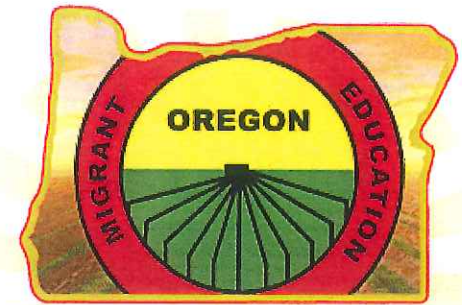

PROGRAM DESCRIPTION

Migrant Education funds support high quality education programs for migratory children and help ensure that migratory children who move among the states are not penalized in any manner by disparities among states in curriculum, graduation requirements, or state academic content and student academic achievement standards.

WHO QUALIFIES?

Children and young people ages 3 to 21 years old:

- Who have not graduated from high school or received a GED
- Who made a move to engage or actively look for, however temporary, for qualifying work
- Who move so they, their parents or guardians could look for seasonal or temporary work
- Whose families depend on agricultural, fishing, or forestry work to survive
