The Kirby School Board met in a special session in the Kirby School District Board Room on Wednesday, May 9, 2018. President Darla Crump called the meeting to order at 5:30 pm with Angie Turner leading a prayer.

Angie Turner made a motion, seconded by Blake Harmon, to approve purchase from American Bus Sales for 12 passenger/handicap school bus in the amount of \$54,900 out of Title 6B and Enhanced Transportation funds pending ADE approval. The motion carried. (4-0)

Angie Turner made a motion, seconded by Blake Harmon, to hire Leigh Ann Nivens as High School Science Teacher for the 2018-2019 school year.


The motion carried. (4-0)
