

INVITATION TO BID

PURCHASE OF COMBINATION TOUCHLESS BOTTLE FILLING STATIONS AND WATER FOUNTAIN UNITS

The Marion County Board of Education is accepting **sealed** bids for the purchase and installation of 20 (twenty) combination touchless bottle filling station/water fountains divided among 10 (ten) locations throughout the Marion County School System with an option to purchase up to 15 additional installed units at the bid price within 30 days of award. This will include the removal of existing water fountains from the wall and installation of the new systems in their place. Marion County Schools will be responsible for disposal of all old fountains from the school locations after removal by the winning bidder. School locations will include Phillips Elementary School and Phillips High School (Bear Creek, AL), Hamilton High School, Hamilton Middle School, Hamilton Elementary School, Marion County Alternative School (Hamilton, AL), Guin Elementary School, Marion County High School (Guin, AL), Brilliant Elementary School, Brilliant High School, and Hackleburg Elementary School and Hackleburg High School (Hackleburg, AL).

The bid price must be valid for a period of 60 (sixty) days beginning on the date the winning bidder is notified. The bid price must include the costs for delivery, removal of existing water fountain units from the wall, and installation of the new units at locations listed above. All bidders **may** list options, upgrades and accessories on a line-item basis and the bid price for those options must also be valid for a period of 60 (sixty) days. A detailed list of **required** specifications is listed below and any further questions can be directed to Mr. Chad Williams, Maintenance Supervisor, at (205)921-3771.

All attached descriptions should be carefully read for required equipment options and dimensions. The sealed bids will be publicly opened on Wednesday, March 22, 2023 at 2:00pm CST in the Board Room of the Marion County Board of Education located at 188 Winchester Drive, Hamilton, Alabama. The results of the bid will be presented to the Marion County Board of Education at its next schedule meeting for action.

The outside of the sealed bid must be clearly marked “**BID 23-06 Bottle Filling/Water Fountains**”. The Marion County Board of Education reserves the right to reject any and all bids or parts of bids. Payment will be through normal Board payment procedures. Invoice items are to be Net 20 days from the date of satisfactory installation as determined by the Marion County Board of Education. Late bids will not be opened. MCBE is not responsible for bids lost in the mail. A bid bond will not be required for this bid. All bidders must conform to all Federal requirements for bidding and must not have been previously debarred from bidding by the United States or any agency thereof; or the State of Alabama, or any agency, or subdivision thereof.
