IV. ACTION/DISCUSSION ITEMS

- FACILITIES UPDATE-INFORMATIONAL-NICK PANCHEAU SHOWED THE DRAFT PRESENTATION FOR PUBLIC MEETING ON THURSDAY. HE DISCUSSED DIFFERENT UPGRADES IN THIS BUILDING ALONG WITH THE BUILDING OF THE SCHOOL. FURTHER DISCUSSION ON USE OF LIBRARY DURING NON SCHOOL HOURS AND HAVE A SEPARATE ENTRANCE. ONE PROCESS WOULD BE MAKING CURRENT KITCHEN INTO WARMING KITCHEN, ETC. REVIEW SITE PLAN. REVIEW PROGRAMING OF WHAT HAS BEEN DEVELOPED. DISCUSS FAQ AND BALLOT BOND LANGUAGE. SHOWING SOME DIFFERENT LAYOUT 3D PHOTOS, ETC. DISCUSSED VIDEO OPTION. CAN WE DO IT? KEEP IT TO TWO MINUTES. - b. WATER UPDATE-INFORMATION/ACTION-DISCUSSED THE POSSIBLITY OF GETTING THE PROJECT STARTED WITH THE CURRENT AARPA FUNDS ALLOCATED WITH SCOTT ASPENLEIDER NEED TO APPROVE FINAL CONTRACT BUT WE CAN WAIT IF WE NEED THE FULL BOARD TO APPROVAL. IT WAS DECIDED TO MOVE FORWARD WITH BOARD MEMBERS PRESENT. OTHER GRANT IS STILL IN LIMBO. IF WE HAVE TO WAIT UNTIL JULY THAT WILL PUT THE PROJECT BACK AND CAUSE AN ISSUE. - d. COVID UPDATE-IT IS STILL GOING THROUGH THE SCHOOL BUT HAS STARTED TO TREND DOWN. WE NOW HAVE THE SPRING COLDS GOING THROUGH THE BUILDINGS. WE HAVE IMPLMENTED THE NO MASKS ON BUSES PER CDC GUIDELINES. WE ARE STILL DOING THE EXTRA CLEANING, ETC. EVEN WITH THE COST WE ARE SEEING THAT BOTTLED WATER IS HELPING TO NOT SPREAD GERMS.
- e. BUDGET UPDATE-MODEST INCREASE IN ELEMENTARY AND HIGH SCHOOL FOR 2022-23. WE ARE ALSO FACING INCREASES IN HEALTH INSURANCE, FUEL ETC. MOST SUPPLIES WE CAN USE ESSER FUNDS FOR. INCREASE OF ENROLLMENT WILL CONTINUE TO HELP. LOOK AT OUT OF DISTRICT STUDENTS. 4 DAY WEEK MAY END UP INCREASING SOME OUT OF DISTRICT AND MAY ALSO BRING BACK STUDENTS THAT CURRENTLY GO OUT OF DISTRICT. ELEMENTARY WOULD BE AROUND \$1.7 MILLION AND HIGH SCHOOL WOULD BE AROUND \$1.2 MILLION. ELEMENTARY HAS IMPROVED AND HIGH SCHOOL HAS IMPROVED ALSO. WORKING THROUGH BUDGET WITH FINE TOOTH COMB TO BE ABLE TO EVALUATE PRE-SCHOOL. TEXTBOOKS, PD ETC. STUDENT POPULATION IS DRIVING FORCE OF BUDGET. DISCUSSED OOD FEES AND THE REASON BEHIND US NOT CHARGING FEES.
- f. APPROVE RESOLUTION OF INTENT TO IMPOSE AN INCREASE/DECREASE IN PERMISSIVE LEVIES-ACTION-NEED TO GIVE AN ESTIMATE TO LET THE TAXPAYERS KNOW.
