  - Graduation rate was 90%, also improved 5<sup>th</sup> year rate by graduating students from previous year.
  - The cafeteria served 13,404 breakfasts and 21,732 lunches at no cost of student's or families.
  - Progress is being converting to charter school. We expect to open the doors to McKenzie River Community School in the fall of 2018. Staff and students are excited about the prospects.
