Terms: I, the undersigned, acknowledge that I am a parent of a Laredo Independent School District student and have voluntarily accepted the option to have my child be issued a student device (laptop or Chromebook) in connection with my child's education with the District for the duration of his/her enrollment in the District up until the end of his/her 8th grade year or withdrawal knowing that I am not obligated to do so as a condition of my child's educational process.

As a condition of acceptance, compliance at all times to the Laredo Independent School District's Parent/Student Device Handbook and Acceptable Use Policy is required. Any failure to comply may terminate your child's rights of possession and the District may exercise its right to repossess the device.

Title: It is understood and agreed upon that the device is, and shall remain, the property of the District. At no point in time can this device be sold or pawned. This agreement does not constitute any transference of property rights in the device. I shall not remove from the device, or permit to be removed, any serial number, model, name, or other indicia showing ownership.

It is the responsibility of the student to make sure the device is in working condition and is responsible for initiating the work order process if this is not the case. (See Student/Parent Device Handbook)

Loss or Damage: Loss, theft or any structural damage of the device must be reported to the District no later than the next school day after the occurrence. If the incident occurred outside of District property, a police report must be turned in to the District as soon as it becomes available. After review of the incident, you may be held responsible for the reasonable cost of repair or its fair market value on the date of loss. (See Student/Parent Device Handbook)

Repossession: Failure to comply with all terms of this Agreement and the Parent/Student Device Handbook, including the timely return of the device as designated the District, will result in the District using reasonable means to attempt recovery of the device.

Term of Agreement: The right to use and possession of the device terminates no later than the date designated by District for the school year unless otherwise terminated by the District or upon withdrawal from the District.

Appropriation: Failure to timely return the device and the continued use of it for non-school purposes without the District's consent may be considered unlawful appropriation of the District's property.
