\$1,140,000 Building Bonds of 2018, dated June 1, 2018 (\$1,140,000 outstanding in principal as of the 12th day of February, 2019).

Construct, furnish, equip, and/or acquire a new classroom addition (511 Washington St., Pocasset, Oklahoma) to include, but not be limited to: HVAC equipment \$255,000.00

Construct, furnish, equip, and/or acquire improvements at the existing Elementary Cafeteria (511 Washington St., Pocasset, Oklahoma) to include, but not be limited to: HVAC equipment and carpentry \$60,000.00

Construct, furnish, equip, and/or acquire an elementary classroom addition (511 Washington St., Pocasset, Oklahoma) to include, but not be limited to: steel and steel erection \$33,000.00

Construct, furnish, equip, and/or acquire roof repairs at the old high school gymnasium (401 East Main St., Amber, Oklahoma) to include, but not be limited to: general requirements and contingencies \$87,000.00

2018 Issue

Construct, furnish, equip, and/or acquire a new Gymnasium/Activity Center (401 East Main St., Amber, Oklahoma) to include, but not be limited to: plumbing fixtures, gym floor, flooring, and specialties \$450,000.00

Construct, furnish, equip, and/or acquire a new classroom addition (511 Washington St., Pocasset, Oklahoma) to include, but not be limited to: electrical panels and sub panels and electrical fixtures \$265,000.00

Construct, furnish, equip, and/or acquire improvements at the existing Elementary Cafeteria (511 Washington St., Pocasset, Oklahoma) to include, but not be limited to: kitchen equipment, sealants and waterproofing, doors, door frames and door hardware, aluminum framing, windows, glass and glazing, and specialties \$185,000.00

Construct, furnish, equip, and/or acquire an elementary classroom addition (511 Washington St., Pocasset, Oklahoma) to include, but not be limited to: general trades \$120,000.00
