# A. Student Representative Report – Hudson Parker

Student Representative Hudson Parker presented a brief update from the student body. School starts in 2 weeks, and fall sports officially began today. The 2022 GPS Back to School Bash was held on Wednesday, August 3, and an estimated 2500-3000 people attended the event. Hundreds of students received free backpacks, school supplies, GPS shirts, meals, and snacks and participated in several games and activities. Although the event was moved indoors due to weather, it was a successful event. The event was made possible due to generous donations from several local businesses and organizations and was successful due to the help of several volunteers.

# B. Superintendent Report – Linda Van Houten

Superintendent Linda Van Houten provided a safety update for the district. Highlights include: The Smart Boot System has been installed across the District, the District has partnered with the City of Greenville Department of Public Safety to secure a School Resource Officer - Josh Vandermeulen, who has already started with GPS, and our PA system is getting upgraded and will be fully implemented in January 2023. Comfort Dogs will be available in each school building but several are still receiving training and should be ready by January 2023. Satterlee School and the Central Services Facility have also received some security upgrades.

# C. Assistant Superintendent Report – Matt McCullough

Assistant Superintendent Matt McCullough provided a Summer Learning report and a brief presentation about the District's new app and website. Matt also presented the 2022-2023 Professional Development Plan and Assessment Calendar.

### D. Director of Human Resources Report - Lisa Steed

Director of Human Resources Lisa Steed provided a full staffing update for the District. Overall, GPS is in a good position, with nearly all professional positions filled. The Transportation Department is also fully staffed, including some permanent substitute drivers.

# E. Superintendent Search Update - Norice Rasmussen

Board President Norice Rasmussen provided a brief Superintendent Search Update. Stakeholder feedback and input closed on July 22, and an updated profile was added to the job posting on July 26. The application deadline is Friday, August 19, 2022, and the Board will meet during the special board meeting on Thursday, August 25, in closed session to review and select applicants for interviews on August 29, 30 & 31. Final interviews will take place on Tuesday, September 13, 2022.

### F. Class of 2023 Senior Mystery Trip – Linda Van Houten
