6. ACTION ITEM (OPEN SESSION)

During the time of this expulsion, the student shall not be on Greenville Public Schools grounds or attend any function at the District without prior written approval from the administration.

The student will be allowed to attend Satterlee School as an alternative educational option and will not be allowed to attend the Satterlee School building in person unless otherwise determined by the superintendent in consultation with the building administration.

The student may apply for reinstatement prior to the start of the second semester or as allowed by State Law.

Reinstatement will be contingent upon the following criteria:

- **Proof of ongoing counseling**
- **Evidence of successful academic progress**
- **Successful completion of court involvement**
