6. ACTION ITEM (OPEN SESSION)

Gardner, based on the preponderance of the evidence, and after careful consideration of the pre-disciplinary factors required by law, that student 05/09/2023 be expelled for 180 days due to assault, which is in violation of the student handbook and district policy.

During the time of this expulsion, the student shall not be on Greenville Public Schools grounds or attend any function at the District without prior written approval from the administration.

The student will be allowed to attend Satterlee School online as an alternative educational option and will not be allowed to attend the Satterlee School building in person.

The student may apply for reinstatement at the end of the expulsion period or as allowed by State Law.

Reinstatement will be contingent upon the following criteria:

- **Proof of ongoing counseling**
- **Evidence of successful academic progress**
- **Successful completion of court involvement**
- **Threat Assessment**
- **Restorative Meeting with Assistant Principal Mr. Mark Haist**
