The student will be allowed to attend online as an alternative educational option and will not be allowed to attend the Satterlee School building in person.

The student may apply for reinstatement at the end of the expulsion period or as allowed by State Law.

Reinstatement will be contingent upon the following criteria:

- Proof of ongoing counseling
- Evidence of successful academic progress
- Successful completion of court involvement
- Threat Assessment
