April 20, 2023

Wednesday, April 19, 2023 President G. Allen Crist called the regular meeting of the River Ridge Community Unit School District #210 Board of Education to order at 7:00 PM. Board Members G. Supt. Fox reported on the Jo Daviess Carroll Career Technical Education Academy minutes from April 3, 2023. Kitchen Partnership Agreement was approved. Manufacturing Day was a huge success. Seven high schools sent their students and they were introduced to 10 companies/industries at the CTEA.
