

The probationary period of September 1, 2022, through August 31, 2026, is tentative and conditional only. Except to the extent required by the applicable provisions of Section 3012 of the Education Law, in order to be granted tenure the teacher must receive composite or overall annual performance review ratings, pursuant to Education Law Section 3012-d of either Effective or Highly-Effective for the required number of years and if the teacher receives an Ineffective composite or overall rating in the final year of the probationary period, the teacher shall not be eligible for tenure at that time.

Mrs. Champney stated that Brian Jeker received 185 votes and Erik Sculley received 181 votes.

Ms. Sexton asked Ms. Black to comment on the process that was used for counting.

Ms. Black stated that there were three Election Inspectors, one was nominated as the Chairperson and that person read the votes. She said that she looked over that person's shoulder to ensure that the

ballot votes were being read correctly while also having view of the two people who were tallying the votes. Every twenty ballots, the tallies were compared to be sure they were the same.

Ms. Sexton reminded the Board that the previous count was done by four poll clerks splitting the ballots into two piles and separating into two teams with one person each reading the votes to one person tallying, with no cross-reference.

Mrs. Champney thanked Ms. Black for recognizing the irregularities in the first certification and for the work done to gather materials and information for the petition to the State. She also thanked Ms. Sexton and Mrs. Gillette for all the work they did in preparation of the petition.

Ms. Sexton thanked the Board for being able to come together for the special meeting and thanked Attorney, Frank Miller for stepping in to assist in changing the way the District petitioned to include the candidates as participants instead of respondents.
