

E. COMMENTS FROM THE PUBLIC

Brandy Miller is a Lisle resident and co-director of Youth Club wrestling and President of Wrestling Club and stated that she is speaking as a parent advocate for student athletes. She said that she is feeling highly discouraged that wrestling will be facing hurdles to have a successful season this year after a recent situation with High School girls who are pursuing wrestling, noting that students should not be discouraged from sports. She said that this year, the wrestling club is purchasing singlets for the Varsity wrestling team and asked what the uniform schedule is and how it is determined. She said that Wrestling Club is responsible for paying for custodial and cafeteria staff when they use the school facilities and asked if other groups are responsible for this as well. She asked why football cannot use the scoreboard or concession stand for home games. She also asked why the district did not apply for the free school lunch grant which she believes was applied for by surrounding districts and also why the district uses a program that charges a fee to add funds to students' accounts.

Alexis Ayers, Lisle resident stated that she is the mother of three students (one who graduated last year) and is invested in many clubs and groups. She stated that she was there to support and advocate for a girls' wrestling team by sharing her daughter's wrestling experience. She said that her daughter wrestled boys most of the season last year and that Section IV had enough girls at the end of the season to hold an all-girls sectional wrestling championship and her daughter was able to participate in that. Gracin Ayers became the first woman wrestler in Whitney Point history to win a Section IV title. Gracin was encouraged by her wrestling coaches to attend the NYWAY tournament held in New Jersey (New York Wrestling Association for Youth) and placed 3rd at state level against other girls. She stated that her husband wrestled for Whitney Point and his life was positively and dramatically changed by the experience. She said that creating a girls sanctioned wrestling program at Whitney Point and giving an equal opportunity for girls to have a girls' wrestling program would expand opportunities and benefit so many.

Carter Stone is a town of Barker resident and a recent graduate who helps coach youth wrestling and has helped with Varsity as well. He stated that there are multiple girls in the youth wrestling program who mostly wrestle boys and sometimes other girls. He said that last year there were two high school females who participated in the State competition on Long Island after competing in Sectionals. Mr. Stone said that there is currently more physical testing in place for females to join wrestling because they need to be on the boys' team. He stated that there is a lot of support in Section IV for girls' wrestling and other schools have tried to put together girls only practices outside of school groups. He suggested getting together with other schools to practice with other girls.

Linda Burghart, Lisle resident asked how to get her questions answered. She also asked where the proposed policies for first reading can be found.

Stephen Klock, Lisle resident stated that he attended a Board meeting about a year ago and mentioned the lack of uniforms for the marching band and said that the Columbus Day parade came and went and there were still not uniforms for the marching band. He said that if you join band, you are required to also be in the marching band and students are required to purchase windbreakers. He said that the band was announced as the Whitney Point *Golden* Eagles, which made him happy. Mr. Klock also said that when he attended school at WPCSD, there were teachers who taught Driver's

Education at no cost and now there is no Driver's Ed program at all. He said he would like to see something started again for the students even if there were a fee to participate.

I. SUPERINTENDENT'S UPDATE

Ms. Sexton presented the Governor's Proclamation in recognition of the School Board.

Ms. Sexton mentioned the interest in girls wrestling this year and stated that the district is watching very closely what's happening with girls wrestling. She said that she has talked with the wrestling coach, Bill MacNeill and that it is a fluid situation.

Ms. Sexton talked about modified cheerleading stating that our IAC league does not have modified cheerleading, but we can possibly create other opportunities for 7th and 8th grade girls to develop a cheerleading club. She said that conversations will need to be had with Youth Club on this.

Regarding restroom use for sporting events, Ms. Sexton stated that there is an obligation to ensure our facilities are secure. The new project will have restrooms accessible as stand-alone restrooms that will not compromise the security of the rest of the school. In the short term, continuing use of port o johns is the best option for sporting events.

Ms. Sexton stated that the district works with BOCES regularly for food services. She said that she would like to know more about what grants specifically Ms. Miller was referring to that surrounding schools have applied for. Ms. Sexton said that the district feels it is unfair that we do not qualify for certain programs that have been looked into and said that she will reach out to other districts to find out if there are any grants the district may have missed applying for.

Ms. Sexton spoke on Mr. Klock's Driver's Education inquiry stating that the district has previously offered it and that the program requires a certified teacher. Ms. Sexton said that since the pandemic, we have not advertised for this position.

Ms. Sexton stated we are working on a number of things to improve safety and security in all of our schools. We will be getting information from students, parents, teachers about what it's like to be a student in our schools and what is not what it should be to work better. She said that the district used to have Olveus which no longer seems to meet the needs of our students. We are looking for options that work for middle and high school students.

J. COMMENTS FROM THE PUBLIC

Megan Ballard, Whitney Point resident and President of Youth Club stated that she would like to be addressed with any Youth Club questions or issues. She referenced bullying issues that her child has had in school and wanted to give credit to Ms. Sexton for her open communication and assistance and she thanked Mr. Kucher and Kristen Galusha for their efforts with this and what they provide for the students. She said that she truly thinks that what Community Schools is doing is amazing. She said that she feels there are issues that need to be addressed more than they are and that she looks forward to moving forward in a positive way.

K. BOARD OF EDUCATION COMMENTS

Mrs. Champney thanked Ms. Ballard for her comments and for planning to be involved with the district moving forward with those efforts.

Mr. Tasber stated that he has been a member of the district for about 32 years and one of the reasons that he chose Whitney Point was the way that students in this district treated other students.

Dr. Widdall thanked Ms. Ballard. She said that this community has kindness within it, and she looks forward to positive direction. She apologized for the lack of follow up about the band uniforms.

Ms. Sexton stated that the district did have turnover within the music department and was previously looking at uniforms but that it would need to be readdressed.

Mrs. Champney stated that the reason the students pay for the windbreakers is that they are personalized and the uniforms the district has are older, uncomfortable, 100% wool, and there are not have enough for the whole band.

Ms. Moseman stated that she is encouraged to see all of the things the CEA and Community Schools is doing. She said that she appreciates all of the comments that Ms. Sexton had on the topics that were brought up by the community. She thanked Ms. Ballard for her comments. She thanked Ms. Ayers for sharing her thoughts and feelings regarding girls' wrestling.

Mr. Jeker stated that he went to the girls' field hockey championship game and that it's amazing to see all of the different students that have gone through this program and to still see such talent in the program.
