RESOLUTION abating the tax heretofore levied for the year 2017 to pay debt service on General Obligation School Bonds (Alternate Revenue Source), Series 2017, of Community Unit School District Number 6, Macoupin and Madison Counties, Illinois.

WHEREAS, the Board of Education (the "Board") of Community Unit School District Number 6, Macoupin and Madison Counties (the "District"), by resolution adopted on the 27th day of February, 2017 (the "Bond Resolution"), did provide for the issue of \$2,850,000 General Obligation School Bonds (Alternate Revenue Source), Series 2017, of the District (the "Bonds"), and the levy of direct annual taxes sufficient to pay the principal of and interest on the Bonds (the "Pledged Taxes"); and

WHEREAS, on the 8th day of March, 2017, a duly certified copy of the Bond Resolution was filed in the offices of the County Clerks of Macoupin and Madison Counties, Illinois (the "County Clerks"); and

WHEREAS, the Bond Resolution established a special fund of the District known as the "Alternate Bond Fund of 2017" (the "Bond Fund") for the repayment of the Bonds; and

WHEREAS, the Board hereby determines that Pledged Revenues (as defined in the Resolution) or other lawfully available funds are available and on deposit in the Bond Fund in an amount sufficient to pay the principal of and interest on the Bonds when due, so as to enable the abatement of all of the Pledged Taxes levied for the year 2018; and

WHEREAS, the Board hereby further determines that it is necessary and in the best interests of the District that the Pledged Taxes levied for the year 2018 to pay the Bonds be abated in their entirety:

Now, Therefore, Be It and It is Hereby Resolved by the Board of Education of Community Unit School District Number 6, Macoupin and Madison Counties, Illinois, as follows:

Section 1. Incorporation of Preambles. The Board hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does incorporate them into this Resolution by this reference.

Section 2. Abatement of Tax. The tax heretofore levied for the year 2018 in the Bond Resolution shall be abated in its entirety.

Secretary of the Board shall file a certified copy hereof with the County Clerks and it shall be the duty of the County Clerks to abate said tax levied for the year 2018 in accordance with the provisions hereof.
